#### PRESIDENT'S REPORT:

Yes, me again. Having attended the AGM last September, far from passing the President's roll to a successor not only did I leave still as the President, but also added the role of Treasurer to the list. Still, no matter, as we have several changes to set up and settle in to our future. We are lucky that enough members put their hand up to serve on the Board, so they were all elected unopposed. We were pleased to welcome Steve Farr as our new Secretary and Richard Waterfield has also joined the board.



I referred to changes that we have started to implement.

Most importantly we have changed our bank from Westpac to the Bendigo Bank. The Toy Fund now has its own separate interest-bearing account. We also have an interest earning account for Building and Donations. The third account is our operating account. This, along with changes, for not-for-profit organisations like us, introduced by the government, mean we have had to return our EPTOS machine. Replacing it is proving a longer process than we had thought, so for the moment we remain a cash only club.

I referred to changes to organisations such as ours as we are now required to improve our accounting and reporting process. Whilst there is no suggestion our accounting was not accurate it was just not fit for purpose under the new regulations. Alongside our new bank accounts, we have now introduced a programme called 'Cash Flow' to help monitor our monthly reports.

Unfortunately, we have had notice of a further death of one of our members. Barry Peick passed away recently and once again Skeeta has been asked to say a few words on behalf of the club. On the plus side we continue to recruit new members.

I am often asked which day is the best day to attend in order to guarantee a lathe. On the whole the workshop is being well used, though there is the occasional day when the number of members using the club is rather low. It is important that numbers using the workshop remain high. Firstly, our instructors give up a lot of their own time and they do not always bring their own projects, expecting to be helping members. Secondly, we need a certain number of attendees, paying their \$5, in order to meet the monthly financial commitments of the club.



Talking of instructors, we will soon be reaching the end of the training course run by Skeeta on Thursday afternoon. Congratulations to those members who have managed to stay the



I look forward to seeing as many of you as possible at the EGM and Club meeting... Peter.




